



NOTICE OF ANNUAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN that the Annual Meeting of Shareholders (the "Meeting") of Westhaven Ventures Inc. (the "Company") will be held at the Terminal City Club located at 837 W Hastings St, Vancouver, BC on **Thursday, July 9, 2020 at 10:00 a.m.** for the following purposes:
